We also expand availability of different contraceptive methods and increase community awareness of, demand for, and use of modern FP methods. We strengthen postpartum FP services and integrate FP into other health services (such as immunization programs) to increase opportunities for women to access care, including nomadic populations. And we work with governments and local partners to strengthen their service delivery platforms at both facility and community levels to help women and their partners."

- "First-Time and Young Parents- While delaying pregnancy is a key goal for ASRHR programs and adolescent pregnancy rates have dropped since 1990, millions of adolescent girls still become pregnant each year. Working with firsttime and young parents, and their families and communities, we build skills for healthy decision-making, foster supportive gender and social norms, and increase access to reproductive, maternal and newborn health services."
 - ♦ This, of course, means abortion, contraception, and sterilization.

- "Family planning and post-abortion care are two critical components of the MISP that are often overlooked."
- "Postabortion care is a package of interventions that offer emergency,
 lifesaving treatment for women who experience complications due to unsafe abortion or miscarriage. A woman's ability to access emergency obstetric care,

- including postabortion care services, is critical for maternal and child survival, particularly in humanitarian settings. Each year, approximately 20 million unsafe abortions occur resulting in an estimated 7 million hospitalizations. In humanitarian settings, women and girls may not have access to contraceptives and health services leaving them more prone to unintended pregnancies."
- Story featured in this brochure: "Angelique* has five children and lives in Mahama Refugee Camp. She experienced heavy bleeding and came to the maternity for help. At the clinic, she learned she was two months pregnant and experiencing a miscarriage. The nurses provided postabortion care services to stop the bleeding. She had not heard about family planning in the past. As part of her care, the nurses gave her information and counseling on family planning. With that information, she decided to start using an intrauterine device. "I am grateful and thankful to the midwives for saving my life."

 - ◆ "Save the Children aspires to ensure that all women and girls in crises are respected and supported in their reproductive health choices, and have access to the Minimum Initial Service Package (MISP) for reproductive health through our humanitarian health programming, with an emphasis on family planning (FP), post-abortion care (PAC) and comprehensive abortion care (CAC). Over more than eight years, support from a large anonymous donor for the Family Planning and Post-abortion Care Global Award (2014-2021) helped us strengthen our capacity and cement our commitment to reach more women and girls with MISP services in acute and protracted emergencies."
