People will be forced to give birth. They'll be forced to seek unsafe abortions. This is the outcome of a decades-long campaign to control the bodies of women, girls, and people who can become pregnant. And it paves the way for unprecedented state legislation to criminalize abortion, as well as other bills that will aim to strip human rights from people in the United States, including the potential for bills that will affect access to birth control, gender, and marriage equality, as well as other anti-discrimination laws.

"WHAT IS THE SOLUTION? -Protect the rights and lives of LGBTQI+ people. Governments must implement comprehensive frameworks for protecting the rights of LGBTQI+ people, not only decriminalizing marginalized gender identities but also ensuring equal and full access to healthcare and protections from discrimination in policing, housing, employment, and **all other aspects of life.**"

Amnesty's USA National Director for Programs, Tarah Demant, condemned the U.S. House for passing an anti-transgender youth bill in April of 2023:

The bill purports to protect the rights of women by restricting the rights of transgender students from playing on women's or girls' sports teams and seeking to amend federal law to redefine sex as being recognized solely on a person's reproductive biology and genetics at birth. Transgender women are women, and legislation that seeks to curtail their rights or erase them does not in any way protect cisgender women.
