Janette McCarthy Wallace, general counsel for the NAACP, released a statement on behalf of the NAACP regarding the six-week abortion ban that was passed in Florida in April 2023. Here is an excerpt from the statement:

It is unconscionable that during Black Maternal Health Week, the Florida Legislature has chosen to undermine, instead of support Black mothers and their families. It's a blatant violation of Floridians' right to privacy, and a threat to every person's fundamental human rights.

WHEREAS, The National Association for the Advancement of Colored People ("NAACP") acknowledges reproductive justice as a core principle of civil and human rights and seeks to protect the right of all women, especially African-American women, to exercise their reproductive freedom and bodily autonomy safely.

The above article shows the relationship between the NAACP and Planned Parenthood, who partnered with and coauthored a letter with Democratic politicians to call out Congress over racial disparity and "lack of reproductive freedom" by not allowing DC to have the same political power and structure (e.g., two senators and one representative) as the 50 states.

Together, they call on the U.S. Senate to follow the lead of the House, rectify the disenfranchisement of the more than 712,000 D.C. residents, and give them control over their bodies, lives, and futures by passing the <u>Washington, D.C. Admission Act.</u>

Over the past few months, legislators in Texas have passed archaic policies, disguised as laws, that directly violate privacy rights and a woman's freedom to choose, restrict access to free and fair elections for Black and Brown voters, and increase the risk of contracting coronavirus.

This so-called infringement included The Radiance Foundation's news article that detailed the NAACP pro-abortion actions, suggesting a name more befitting of the abortion-pushing organization: The National Association for the Abortion of Colored People. Apparently, truth and parodying an organization's name are not protected under the First Amendment.
