• <u>Katie Fitzgerald</u>, Ronald McDonald House Charities' CEO, was CEO of <u>Feeding</u> <u>America</u> when it released a statement condemning *Dobbs v. Jackson* in 2022:



"The recent U.S. Supreme Court decision to overturn Roe v. Wade will have deep implications for hundreds of thousands of women and pregnant people particularly people of color and people with low income—as well as children and families. The data clearly demonstrates these

individuals and families will be significantly more likely to remain in poverty or fall below the poverty line. It stands to reason then that **the ruling will stretch already limited budgets, in the middle of historic inflationary pressures, resulting in more economic hardship** and increased reliance on federal nutrition safety net programs, which will not be enough to cover the costs of food for those in need."

 Warren Maxfield, RMHC of Idaho's former director of programs and development, has gone back and forth between working for RMHC and Planned Parenthood of the Great Northwest and the Hawaiian Islands.
