## **Stance on Abortion and Contraception**

FINCA International's 2021 "World Population Day" blog post highlights their support for contraception and the UN's pro-population control agenda as they describe the impact COVID-19 had on "women's sexual and reproductive rights." Below is what FINCA says about COVID's impact on access to contraception:

The United Nations sanctioned World Population Day in 1989 to raise awareness about population and its effects on development and the environment. Important issues as diverse as family planning, gender equality, poverty, maternal health, and human rights all touch on population. More than 18 months into the COVID-19 pandemic, the world is in a transitionary phase... Against this backdrop, this year, World Population Day highlights the pandemic's impact on fertility... The pandemic also wrecked health systems around the world, including sexual and reproductive healthcare. Family planning and contraceptives are among the most disrupted services. Decision-makers had to reallocate resources and sometimes close institutions. These actions severely limited access to essential health services for women in several countries. Supporting the human rights and wellbeing of women and girls around the world is crucial in addressing these population-related issues. At FINCA this means stepping up efforts to educate and economically empower women. It also means eliminating discriminatory behaviors and practices that disadvantage women, something FINCA targets through its programs as well as through its hiring and training programs in the countries in which it works.

In a report from 2007, Microfinance Opportunities (MFO) published a document entitled *Study of the Demand for Health Financing Services among FINCA Uganda Clients.* On page 39 of the document, MFO interviewed FINCA employees and clients, who stated that HIV/AIDS rates are more prevalent among teenagers and young adults "because these populations are sexually active, and many people **do not use safe sexual practices**."

On page 41 of the document, they also cite the following about condom use:

Although respondents reported using condoms to protect against HIV/AIDS and STDs, women commented that the usage of condoms is not very common. This is because women have less bargaining power when it comes to sexual protection, hence many women cannot demand the use of condoms (Mosser, 1997). Other prevention methods mentioned by the participants included educational seminars provided by the government.

On page seven of their 2021 annual report, FINCA International provides the following information:

In 2018, FINCA's CEO hosted Diana Sierra from the organization Be Girl to promote her organization's education on menstruation for young girls and teens in developing countries. A closer look at Be Girl's education curriculum shows that they also promote contraception to young girls and teens. Section 5 of the curriculum guide goes into graphic detail on how to use condoms and other contraceptive means. The guide also explicitly says not to track your cycle as a mode of family planning. A closer look at the footnotes shows Planned Parenthood and the Mayo Clinic as sources for the explicit sexual "education."
