

American Life League's Latest Research Data Shows That 'Pro-Life' States Are Involved with Big Abortion Business

According to just-released data from American Life League, America has no truly "pro-life" states, as many still allow for abortions early in pregnancy and exceptions in all/most cases (thus we have added quotation marks to the term "pro-life").

Following the news of Planned Parenthood's defunding throughout the country, ALL examined which states have Planned Parenthood facilities, how many facilities are currently open in each state, the most recent Planned Parenthood affiliate income, and which states each of these affiliates operate within.

American Life League has revealed that after the three recent Texas facility closures, Planned Parenthood currently operates 29 facilities in that "pro-life" state. That is more than any pro-abortion state except California (106), New York (47), and now Washington (30). Florida and Indiana, also perceived as "pro-life," have more Planned Parenthoods than the numerous states identified as abortion friendly.

Additionally, ALL discovered that out of the 16 "pro-life" states, Mississippi is the only one without a Planned Parenthood facility. North Dakota and Wyoming are not considered "pro-life" states, but they do not currently have any Planned Parenthood facilities.

Planned Parenthood Great Northwest, Hawaii, Alaska, Indiana, Kentucky has more facilities in "pro-life" states (14 total) than it does in pro-abortion states (4 total), and it earned \$85,439,932 in FY 22/23.

ALL found that the average income of the 41 Planned Parenthood affiliates in pro-abortion states is \$43,389,872. However, 11 Planned Parenthood affiliates in "pro-life" states saw an average affiliate income of \$41,208,358. Clearly there is not much difference in Planned Parenthood's affiliate income in states with more abortion restrictions than those in states with little-to-no abortion restrictions.

ALL also looked at the abortion laws in each state and at the exceptions written into laws. All 50 states and DC allow exceptions for abortion after a certain gestation period in pregnancy.

The four states with heartbeat laws that have "banned" abortion after six weeks gestation allow exceptions for abortion past that time in all or most cases. In 2024, Florida even added <u>an exception for human trafficking</u> into its new "pro-life" law.

The data on the next few pages show how many Planned Parenthood locations operate in so-called "pro-life" states and how many millions of dollars they rake in annually.
