Dear Attorney General Paxton,

On behalf of American Life League, I am writing to share our deep concern about the current situation regarding widespread access and distribution of the abortion pill throughout the United States. We recognize and appreciate your ongoing efforts to address this crisis, and we commend your recent letters<sup>1</sup> that highlight the urgency of the situation.

American Life League's 2024 report<sup>2</sup> on the illegal abortion pill distribution reveals that providers of abortion pills are using strategies similar to those used by drug cartels and are circumventing state and local laws. Abortion organizations such as Planned Parenthood and Abortionfinder.org actively refer women to a network of online sources to obtain these drugs illegally. As you note in your letter, Plan C<sup>3</sup> is one of the networks that does this, which we detail numerous times in our report. These networks not only send these dangerous drugs without any knowledge of the woman's mental and physical health, but they show women how to hide their abortions from doctors, family, etc.<sup>4</sup>

American Life League's most recent report on Planned Parenthood in "pro-life" states also highlights that Planned Parenthood's affiliates continue to earn millions of dollars in annual revenue despite the state's abortion laws.<sup>5</sup> The average affiliate income between abortion-restricted and pro-abortion states is nearly the same. Planned Parenthood currently has 29 facilities in Texas alone, and its affiliates make a combined annual total of \$130,834,049.<sup>6</sup>

Planned Parenthood's involvement in distributing and referring women to other states to obtain the abortion pill shows that much more action is needed to combat the illegal abortion pill cartel.

By outlawing the abortion pill and its widespread distribution, we will be taking a strong stand for the protection of human life at its earliest stage, for the health and safety of women, and for the integrity of our commitment to upholding the dignity of the human person at any stage. We cannot afford to be complacent in this matter; the lives of the most vulnerable are at stake. Scientific evidence proves that life begins at creation, thus requiring that we acknowledge the fact that abortion pills always take the life of an innocent child prior to that child's birth. This reason alone is sufficient to require that these pills be criminalized rather than merely restricted.

Attorney General Paxton, American Life League supports your courage and efforts 100%. We ask that you outlaw and criminalize these deadly abortion pills for the sake of the babies, mothers, and families. Thank you for your time, attention, and action in this urgent matter.
