Planned Parenthood Facilities Report Update: 2025 in Review

Introduction

STOPP's [*2025 Planned Parenthood Facilities Report*](#), released in May 2025, highlighted our research into Planned Parenthood facilities and showed that the number of physical PP locations across the nation continues to decrease due to pro-lifers' prayerful witness and push for legislative efforts. STOPP found that between June and December 2025, four Planned Parenthood facilities opened, 29 permanently closed, and three temporarily closed. With these changes, Planned Parenthood went from 516* operating facilities in May 2025 to 488 facilities by the end of 2025.

Including the 22 closures identified before the release of our May 2025 report, this brings the total number of Planned Parenthood facilities that closed in 2025 to 54 (including temporary closures), setting the record for the most facilities closed in a single year since STOPP began tracking this number in 2003.

This update to STOPP's latest facilities report will break down Planned Parenthood's closures and openings for the latter half of 2025 and discuss what they might mean for the abortion organization's future.

Mergers, Consolidations, and Closures

We saw numerous facility closures and major changes to Planned Parenthood's affiliates throughout the US in 2025. This only happened because of the relentless prayers and diligence of pro-life warriors.

CALIFORNIA

Planned Parenthood of Orange and San Bernardino Counties closed its Melody Health primary care program, which was housed in seven facilities throughout the area. Though PPOSBC stopped offering primary care "services" at these locations, it is keeping the facilities open for "reproductive care services," including contraception and abortion.

MT. BAKER

Planned Parenthood merged its Mt. Baker affiliate into its Greater Washington and North Idaho affiliate.

FLORIDA

In the summer, Planned Parenthood consolidated Planned Parenthood of Southwest and Central Florida and Planned Parenthood of South, East and North Florida into one affiliate—Planned Parenthood of Florida—which covers the entire state.

* Since our May 2025 report, STOPP discovered an additional seven facilities that may have been open at the time of the report or that reopened shortly afterward. This total number has been revised from the 509 facility figure given in our last report to 516 to include these facilities.

PP GULF COAST

The Planned Parenthood Gulf Coast affiliate closed at the end of September. This affiliate had operated in Texas for almost 90 years and in Louisiana for over four decades. PPGC gained national attention in 2015 when the Center for Medical Progress released undercover videos exposing [Planned Parenthood's baby body parts business](#).

Melissa Farrell, who served as PPGC's director of research, also oversaw the affiliate's fetal body parts program. She was [captured](#) on video saying that an "a-la-carte" approach to payment, where buyers only pay for the specific body parts they want to purchase, would be best. Splitting a baby's body into multiple pieces for different buyers was "[just a matter of line items](#)."

Farrell was also open to changing abortion procedures to "preserve the integrity of the specimen [dead baby]." Despite federal laws banning the sale of aborted babies, she told the undercover investigator posing as a buyer that she wanted the situation to be "financially beneficial" for them. Texas and Louisiana barred Planned Parenthood from their Medicaid programs following the investigation, but the organization never faced official charges over its bloody trade.

LOUISIANA

When PP Gulf Coast closed in the fall, some of its facilities were transferred to another affiliate, but four of PPGC's facilities also closed. These closures included the last two Planned Parenthood facilities in Louisiana, making it the fourth PP-free state in the nation.

TEXAS

The other two facilities that closed along with PPGC were located in Houston, Texas, and included the notorious Prevention Park location. This 78,000-square-foot facility opened in 2010 and was once the largest abortuary in the Western Hemisphere. At the facility's peak, when Texas' abortion laws allowed killing through 24 weeks gestation, as many as [10,000 babies](#) were killed within its walls each year. In 2020, our [Marian Blue Wave](#) program devoted an entire month to praying for this facility's closure, and we were thrilled to see its doors shut for good.

NEW YORK

Planned Parenthood of Greater New York also lost a significant facility in 2025. It announced that it was closing its Manhattan Health Center and selling the historic Bleecker Street building that housed it. Formerly known as the Margaret Sanger Center, its name was changed after PP employees [accused](#) PPGNY's CEO of racism, which we covered in our 2020 report entitled [Planned Parenthood's Racism ... In Their Own Words](#). This facility was the only PP location in Manhattan and once operated as the headquarters for the now-closed PP New York City affiliate. It also served as a training center to teach generations of abortionists to kill preborn babies.

Though the fight is far from over, 2025 showed the ever-widening cracks in Planned Parenthood's foundation. Now is the time to capitalize on its instability by defunding it for good.

Analysis

Planned Parenthood has continuously said that abortion accounts for [4%](#) of its "services." However, PPFA President Alexis McGill Johnson [stated](#) in June 2025 that "there is not now, and has never been, a plan to stop providing abortion care in the hopes of preserving federal funding. Any claims to the

contrary are an outright lie.” She continued, “Providing abortion care everywhere it’s still legal is not up for negotiation. We will continue to proudly provide the full range of reproductive health care—including abortion—no matter what.”

Abortion has always been Planned Parenthood’s priority, and its own reported numbers reveal its focus on preborn child killing. Planned Parenthood’s customer numbers dropped by 940,000 between 2007 and 2023, yet its abortion numbers have climbed steadily every year. Planned Parenthood reported 402,230 abortions in 2023 compared to 305,310 in 2007, and that number only includes the abortions that Planned Parenthood commits directly. It also helps kill preborn babies through contraceptives and referrals to other surgical and abortion pill vendors across the country.

Additionally, the organization’s response to its temporary defunding confirms its priorities. Under [H.R.1](#) (also known as the “One Big Beautiful Bill”), affected organizations can restore their Medicaid funding by ceasing abortion “services.” But Planned Parenthood responded with a collective “no,” instead closing even more “primary care” facilities than those that commit abortions. If abortion is only [4%](#) of Planned Parenthood’s “services” and if it is truly concerned about the “[harms](#)” the bill has caused for its patients, wouldn’t it attempt to comply with the provisions and drop such a small portion of its “services”? The reality is that abortion is Planned Parenthood’s [largest moneymaker](#), and as McGill Johnson stated, the organization will never stop its killing.

[Summary of Results](#)

- Since our facilities report in May 2025, 32 more facilities have closed (29 permanently and three temporarily).
- All 54 facilities that closed in 2025 distributed contraceptives, but most (29) did not commit surgical or pill abortions at the time of their closures.
- Four of the 54 facilities that closed offered surgical abortions.
- Twenty-five of the 54 facilities that closed offered pill abortions.
- Four facilities have opened/reopened since May 2025, bringing the total number of openings/reopenings for 2025 to seven.
- Affiliate virtual health centers continue to provide abortion pills after facilities close, with a total of 49 virtual centers in operation as of December 2025. This is up from 43 at the end of May 2025.
- Planned Parenthood is prioritizing closing its contraception-only facilities instead of abortion centers amid its “defunding.”

[Conclusion](#)

The One Big Beautiful Bill temporarily defunded Planned Parenthood of [an estimated \\$700 million dollars](#) for one year, but STOPP does not expect this legislation to be extended or made permanent. The defunding term in the initial legislation was already reduced from 10 years to one year in order to pass. If funding is restored, Planned Parenthood can simply either reopen its physical facilities or invest more in its virtual abortion business. Additionally, Planned Parenthood faces restrictions in each state regarding abortion. Creating an entire virtual business to get around state restrictions for abortion,

while claiming it is only 4% of its services, illustrates that Planned Parenthood truly is an abortion provider, first and foremost.

While we celebrate the closure of this record-breaking number of facilities, we cannot allow temporary victories to weaken our resolve to shut down the abortion giant for good. Planned Parenthood's collapse isn't inevitable, especially if we yield our momentum. It is, however, assured if we continue the spiritual and physical fight to shutter its doors forever.

There are two ways that every pro-lifer can work to achieve this crucial goal. First, pray. We began our [Marian Blue Wave program](#) because we know that abortion is a spiritual battle, and we will only end it through the intercession of our Lord and Blessed Mother. Will you [join us](#) in praying weekly for the closure of every Planned Parenthood facility in the US?

Second, you can fight to defund and close the PP facilities in your community and state. Urge your state legislature to exclude Planned Parenthood from its state Medicaid program, a move that was [upheld by the US Supreme Court](#) in 2025. Several states have already enacted this policy, weakening the abortion giant within their borders. You can also pray outside of local facilities, join sidewalk counselors to reach vulnerable mothers, and speak at public hearings. Make sure Planned Parenthood understands just how unwelcome it is in your community.

Categories of Abortion

In the facilities report, we provide information on how many Planned Parenthood locations commit abortions. Below are the various categories of abortion and the number of Planned Parenthood locations that commit each type.

SURGICAL ABORTIONS: These are invasive procedures in which the person committing the abortion inserts instruments into the mother's womb to cause the death of her child. Planned Parenthood currently has 163 facilities that commit surgical abortions.

ABORTION PILL ABORTIONS (also called "medication abortions"): In these types of abortions, the mother is given drugs to cause the death of her child. This is done using two drugs: mifepristone, which starves the child to death, and misoprostol, which induces contractions to expel the now-dead child from the womb. Planned Parenthood has 210 facilities that commit pill abortions but not surgical abortions. It additionally has 162 facilities that commit pill abortions along with surgical abortions. In total, 372 facilities offer abortion pills.

CONTRACEPTIVE ABORTIONS: Most so-called "contraceptives" (excluding barrier methods) have three means of operation. [Cleveland Clinic](#) explains: "The hormones in birth control pills prevent pregnancy by blocking conception, when sperm fertilizes an egg. They also cause changes in your uterus so that it can't support a pregnancy while you're on the pill." Contraceptives may prevent ovulation, thicken cervical mucus to keep sperm from reaching the egg, or "thin the lining of your uterus so that a fertilized egg [preborn baby] can't attach and grow there." This last mechanism is a contraceptive abortion.

While all but 6 of the 488 Planned Parenthood locations distribute products that cause contraceptive abortions, PP does not include this type of abortion in its data, as there is no way to know or count just how many babies are killed from contraceptive abortions.

IVF ABORTIONS: The fourth category of abortions occurs at in vitro fertilization facilities across the country. During the process of IVF, mature eggs are collected (retrieved) from ovaries and fertilized by sperm in a lab, resulting in an embryo (a new human being). Then the embryo (or embryos) is transferred to a uterus. The IVF process has a number of procedures that result in the death of preborn children. This report does not delve into the specifics since Planned Parenthood is not yet involved with facilitating these abortions. However, it does offer [external referrals for IVF](#).

METHODOLOGY: One physical address = one facility

Methods — Researchers collected data from both the national and affiliate websites of Planned Parenthood Federation of America to examine which facilities are currently in operation, what “services” they provide, and which ones offer telehealth abortions. This research also tracked the number and operations of the organization’s virtual health centers. Where any discrepancies arose, researchers searched for the facilities online to determine which are temporarily/permanently closed or still operational.

Facilities count — Researchers encountered 11 physical locations where Planned Parenthood claimed more than one facility at the same physical address. This most frequently happened when Planned Parenthood was separating its abortion business from the rest of its “services.” In all cases where more than one facility was listed at the same physical address, it was simply counted as one.

Data collection period — The status of Planned Parenthood facilities is a fluid one. New facilities open, old facilities close, and specific “services” at facilities change on a regular basis. This report reflects the situation as of January 6, 2026.
